THE BAR HARBOR FOOD PANTRY MAIN PROGRAM IS TO SUPPLY NON-PERISHABLE FOOD ITEMS TO MEMBERS OF THE COMMUNITY WHO ARE EXPERIENCING FINANCIAL HARDSHIP, AT NO COST TO THEM. DURING 2020 THE FOOD PANTRY SAW A 32% INCREASE IN CLIENTELE AND DEMAND FOR FOOD. THE COMMUNITY WAS VERY GENEROUS WITH DONATIONS TO MEET THE FINANCIAL NEEDS OF THE ORGANIZATION. THE BACKPACK PROGRAM WAS SUCCESSFUL IN RAISING REVENUE TO MEET THE NEEDS OF THE COMMUNITY DURING A DIFFICULT TIME FOR SCHOOL CHILDREN WHO WERE DISPLACED.
